

Minutes of the Regular Council Meeting held in the Municipal Chambers on Wednesday, February 23, 2022, at 5:30 pm

Mayor S. Storey presided. Councillors present were C. LePoidevin and A. Fennema. Councillor K. Watt-Senner and J. Jenkinson joined by video conference.

Staff present were Chief Administrative Officer R. Holland.

Meeting Called to Order at 5:30 pm.

Delegations & Guests:

Sgt Jason Rumming of the Fraser Lake RCMP presented his Annual Report. The report highlighted crime reduction activities, traffic enforcement, an update on detachment staffing resources, the formation of the Violence Against Women in Relationships committee and the detachment's annual performance plan. Sgt Rumming provided his report in a written format.

In reviewing the details set out in his report, Sgt Rumming reviewed the success of their crime reduction initiatives. These activities have been undertaken in conjunction with neighbouring detachment. Through the haring of information and holding offenders accountable to court ordered conditions. Since most of the offenses in our community are attributed to just a few chronic or prolific offenders, this approach has had a significant impact on the behavior of these individuals. Curfew checks in 2021 were up 418 percent, from 33 curfew checks in 2020.

Sgt Rumming reviewed the statistical data generated through the 1516 Calls for service that were responded to by the Fraser Lake Detachment in 2021.

Sgt Rumming reviewed the traffic enforcement activities. Statistically, the final numbers are similar to those generate in 2020. Impaired driving was a strategic focus in 2021, seeing a 40 percent increase in the number of Impaired charges being levied in 2021. In the conduct of these activities, the detachment continues to partner with ICBC, School District 91, Commercial Transport Vehicle Safety and North District Traffic Services. Several of the initiatives stemming from these partnerships include School Bus – red light violators, enhances patrols and speed enforcement in Nadleh and Stellaquo and regional roadways.

Sgt Rumming advises the detachment is making concerted efforts to improve road safety in the community through pro active enforcement activities.

Sgt Rumming discussed the Violence Against Women in Relationships Committee. The group that has been assembled for this purpose is broad based. Service providers include Autumn Services, Connexus, CSFS, Omineca Safe Home, Stellat'en First Nation, Stellat'en FN Health Unit, Fraser Lake Crisis Centre, Nadleh Whut'en First Nation Health Unit, MCFD, Vanderhoof Probation and Vanderhoof Crown Council. Sgt Rumming anticipated the group will eventually become a non-profit Organization.

Sgt Rumming discussed the Detachment's Annual Performance Plan. The three priorities are 1) building and maintaining trust with the Public and Community Partners, 2) enhancing public safety and 3) prioritizing the mental and physical health, wellness, and resiliency of detachment employees.

Mayor Storey thanked Sgt Rumming for his report. She appreciates the various levels of communication between the detachment and the Village. Mayor Storey asked if there were any opportunities for the municipality to assist the police.

Councillor Jenkinson commented on the increased heavy truck traffic on Highway 16. He has not noticed an increase in the number of truck inspections on the highway corridor.

Sgt Rumming advised truck inspections fall into the realm of the Commercial Vehicle Safety Enforcement service. COVID-19 had a Significant impact on everyone's work, including road checks conducted by CVSE. Sgt Rumming anticipate an increase in their activities as COVID restrictions reduce. He also hopes to coordinate several road check blitzes with CVSE and Conservation later this year.

A short discussion followed around road safety and motor vehicle collisions.

Mayor Storey thanked Sgt Rumming again for his time and presentation.

On the same issue, Mayor Storey received a call from Brad McRoberts from the Province. He is also working to resolve this concern.

Mayor Storey attended three days of UBCM meetings.

She attended the Family Day BBQ.

Mayor Storey had a meeting with Tanner Moulton of TC Energy. Mr. Moulton wanted the Mayor to know what was going on with the Nadleh Macro partnership. There has been a commitment to support local business. Tanner Moulton believes local accommodations will be full, as will the Fraser Lake Villa Park.

Mayor Storey also attended NCLGA meetings.

She participated in the Northern Regional Conference Call with Minister Josie Osborne. During the call, Minister Osborne asked each Mayor about their goals for the coming year. What they want to accomplish in this term and what they plan to leave for the next Council. Mayor Storey took the opportunity to plug the community and the goals of the Council. This included telling the Minister about efforts to replace the water tower.

Mayor Storey spoke with the representatives of CityWest at the Family Day event. Mayor Storey feels members of Council can influence the number of people registering for fibre optic service through VFL Communications. She asks members of Council to promote the service when on social media. With larger numbers of subscribers, the more benefit to the community.

Mayor Storey commented on a recent visit to McKenzie, B.C. for hockey. She commented on the quality of their arena and how it is a community gathering space. She feels Council needs to consider the importance of having a community hub such as the Community Hall project. Mayor Storey feels if the Community Hall is built, it may encourage people to move to Fraser Lake

Water Reservoir Replacement Project

CAO Holland advised the grant application to the Investing in Canada Infrastructure program has been submitted. Based on the projected cost of the project, the electronic application calculates the amount of the grant funding and the contribution of the community. The community obligation has increased from \$625,000.00 to \$793,766.00. For our application to be eligible for funding, that amount of money must be committed to the project. An amendment to the previous resolution to reflect the community's obligation toward this infrastructure project.

MOVED/SECONDED to amend resolution 02-09-89 made at the Regular Meeting of Council on February 9, 2022, to increase the community's funding commitment to \$793,766.00 for the replacement of the Water Reservoir, addition of a stirring mechanism, and a chlorine monitoring and injection system to improve the quality and availability of drinking water in our community that meets all public health standards.

Commercial Southside properties:

CAO Holland advised Council it has been seven years since the prices were established for Southside Subdivision commercial properties. In that time, five properties have sold. Twelve properties remain available for purchase. CAO Holland advised there are regular inquires about the properties. Due to the number of years that have lapsed since these properties were priced, Administration was bringing this to Council for review. There is no recommendation from Administration.

A brief discussion followed.

Mayor Storey commented on the development of the expanded card lock facility by the Four River's Cooperative. Upgrades may be required for the intersection of Highway 16 and South Carrier Crescent. If those

improvements are required, the expense would be assessed against the Southside properties by way of a parcel tax.

CAO Holland advised the Village is working with the Ministry of Transportation to determine what is required. Not enough information is available to determine the impact of the Four River's Cooperative development. The improvements to the South Carrier intersection would not be for the sole benefit of the Four River's Cooperative. Improvement of that intersection would benefit the whole subdivision. Some of that cost could be appointed to the southside properties by way of a parcel tax. Once more information is available, that discussion can advance.

MOVED/SECONDED to table the discussion of the improvement to the Highway 16 and South Carrier Crescent intersection until further information is received.

The data presented from the independent speed study appears to have been dismissed but the information provided by incumbent Internet Supplier has been accepted, contrary to the evidence which contradicts their claims. There seems to be a systemic bias that provides Telus with the benefit of the doubt

A brief discussion followed. Council has asked Administration to write Minister Beare a letter to voice Council's concern about her decision and the potential impact that decision could have on northern communities.
