Councillor Fennema

She and her husband judged the floats that participated in the Santa Claus parade on the evening of December 10th. She was very pleased with the quality and quantity of floats and wished she could have provided a ribbon to all the entrants. Public comments about the parade were very positive.

Mayor Storey

Mayor Storey agreed with Councillor Fennema's comments about the parade. Mayor Storey thanked Village staff for their involvement in organizing and participation in the parade. She felt it was nice to see a happy event in the community.

On December 16, 2021, Mayor Storey met with Minister Osborne and Minister Rankin via conference call. The purpose of the meeting was to discuss the activities and initiatives of communities that build relationships and advance reconciliation with First Nations Communities. Mayor Storey highlighted some of the activities undertaken by our Council.

On December 18th Mayor Storey participated in an anti bullying presentation. On that same date, she attended a meeting of the Omineca Response Initiative to discuss mental health.

On January 11, 2022, Minister Malcolmson spoke with NCLGA board members about the mental health of communities and the lack of services. There was discussion around the province's harm reduction initiative to decriminalize possession of small amounts of narcotics. Mayor Storey mentioned a conversation she had with a Sgt in the RCMP about the legalization of narcotics. The Sgt felt the possession of 1 gram or less was fine. However, possession of up to 4 gram of narcotic was excessive. The limits on possession are thought to be too liberal.

Mayor Storey added, that although the Village of Fraser Lake has not been heavily affected by the opioid crisis, we are still affected. She is disappointed there are no new facilities planned for the north.

Canada Summer Jobs

Fisheries Study

CAO Holland highlighted the fisheries study that is underway for Fraser Lake. The video created for the Nechako white sturgeon release into Fraser Lake provides a picturesque view of the lake, our boat launch and White Swan Park.

Community Hall Project

As construction documents are prepared for this project, the refrigeration engineer has proposed an application to CleanBC for up to \$200,000.00 to first conduct an energy efficiency feasibility study at a cost of \$9,000.00. Assuming the project proceeds to construction, the cost of the feasibility study will roll into the construction costs of the project. CleanBC provides funding up to \$200,000.00 for energy upgrades and efficiencies, assuming they are available in our facility.

The CleanBC application will be prepared and submitted on the Village's behalf by Polar Engineering.

Water Reservoir Replacement Project

The specifications for the water reservoir replacement project *Request for Proposals* (RFP) were prepared by Urban Systems. The RFP was advertised. Five submissions were received for engineering services to complete the planning and design for this project. The successful bid has been identified. The cost of completing the Engineered Planning & Design for this project is \$14,500.00. Administration is proposing the cost of this expenditure come from the Northern Capital and Planning Reserve.

<u>VFL Communications – Fibre Optic Internet Service – Partnering Agreement</u>
The Alternate Approval Process (AAP) conducted relative to the proposal to enter into a Partnering Agreement as per Section 21 of the *Community Charter* has been completed.

To notify our residents of the process, a public notice was advertised on two consecutive weeks in the Omineca Express and posted on our Public Posting Board at the Front of the Village Office, as required by the *Community Charter*. The purpose of the public notice was to inform our residents of the Village's intention to enter into a partnering agreement for the purpose of providing high speed fibre optic service to the community. To ensure the public notice was available to our residents, administration took the extra steps of posting the public notice on the Village website, Village Facebook page and shared it with the local social media page *Heck Ya Fraser Lake*.

Following the mandated advertisement in the local newspaper, the process entered a 32-day elector comment period. Eligible residents were provided the opportunity to attend the Village Office and register their opposition to this proposal by way of written submission. To facilitate that process, copies of the partnering agreement and the Elector Response forms were present and available at the front counter of the Village Office. The 32-day elector response period ended at the end of the business day on January 11, 2022. During the electorate response period, Village staff received no inquiries for more information, no inquiries to review the partnering agreement and no written submissions of opposition to the proposed partnering agreement. By way of reviewing the Facebook post

for the public notice, staff were able to confirm that at least 435 persons had accessed the public notice.

MOVED/SECONDED to accept the outcome of the Alternative Approval Process with no registered opposition from Village of Fraser Lake electorate relative to the proposal by the Village of Fraser Lake to enter into the Last Mile Network Infrastructure Partnering Agreement to provide high speed fibre optic internet service to the Village of Fraser Lake.

Telecommunications Tower

CityWest has proposed the installation of a Telecommunication tower on the top of Mouse Mountain. This tower will capitalize on the fibre optic network infrastructure installed in Fraser Lake. The tower will transmit internet and television services to service subscribers in the vicinity of the Village of Fraser Lake. This telecommunications tower will benefit Area D residents from the Fraser Lake Sawmill to west of Stellaguo through this line-of-sight transmission. CityWest will be responsible for the operation and management of the service. Net revenues generated from the telecommunications tower will be managed under the Partnering Agreement. This proposal supports many of the residents who call Fraser Lake home but do not necessarily reside within the Village boundaries. Because this service will operate under VFL Communications, the Village of Fraser Lake will receive 40 percent of net revenues generated by the telecommunications tower.

MOVED/SECONDED to authorize the installation of a telecommunications tower on the top of Mouse Mountain under the conditions of the Last Mile Network Infrastructure Partnering Agreement. Costs of the tower, installation and maintenance will be borne by CityWest and at no cost to the Village of Fraser Lake. Net revenues generated through the operation of this tower will be shared with the Village as per the partnering agreement. Council recognizes this telecommunications tower will provide the opportunity for internet and television services to residents with line of sight to the telecommunications tower who reside in the RDBN Area D.

Councillor Fennema asked when budget discussions would begin.

A brief discussion followed. The first two budget discussions scheduled for Friday January 21 and Friday January 28 from 2:00 pm to 4:00 pm.

Mayor Storey thanked staff for their activities over the Christmas break. She thanked EDO Dave Christie for taking on garbage pick up and Jeff Graham for his good work while the Director of Public Works was away.

Mayor Storey commented on a rail line blockage. Apparently, the CN Rail locomotive had broken down, leaving the train across Park Drive. Two people had to walk through deep snow to get around the train to get home. Mayor Storey was concerned there was no notification from CN about the development and when she phoned the CN Rail call center, the person who received her call stated it could be a couple of days before the train could moved off the intersection. Fortunately, the engineer was able to be the locomotive going and move the train out of the Park Drive intersection.

Councillor Jenkinson was affected by this event. He stated it didn't cause his family any issues. However, he asked if the Village had a plan to get people out if there was an emergency?

CAO Holland suggested there was not a plan for this circumstance, however, our emergency responders would be able to develop a plan in short order based on the circumstances, weather, etc. if an emergency occurred.

Following a brief discussion, it was agreed this type of event is rare.
