Councillor LePoidevin

Councillor LePoidevin attended the Halloween event on October 31, where he grilled hamburgers for the public.

Councillor Fennema attended the Halloween celebration on October 31. She thanked her fellow Council members for their hard work.

Mayor Storey

Mayor Storey attended the Halloween festivities on October 31. She thanked the Chamber of Commerce and Village Staff for all their hard work. She also wanted to recognize the hard work of CAO Holland, Fire Chief Pacheco, Dave Christie, and the other members of Fraser Lake Fire Rescue for the fireworks.

Mayor Storey attended a meeting with the Regional District Bulkley-Nechako (RDBN) about wildfires. Potential improvements to the way fires are managed was discussed. It was agreed that communications are key.

Mayor Storey received an update from Coastal GasLink (CGL). They are now demobilizing the Little Rock Lake Camp, and there will only be 25-40 people remaining to do reclamation work. She went on to tell Council that eight compressor stations have been approved under the Environmental Assessment. Assuming the final investment decision for Phase II is approved, the compressor station between Burns Lake and Fraser Lake will have 200 people in the camp.

Regional transportation was a topic of discussion at the recent RDBN Board Meeting. There was a discussion about changing ticket prices. The Village will be contributing slightly more to this program in 2024.

CN Rail brought plans to the RDBN for public consultation, asset management and vegetation control.

Business from the CAO:

<u>BC Air Access Program – Funding Opportunity – Airport Improvements</u> The BC Air Access Program is accepting applications for 2024 projects. The intake closes at the end of day on December 22, 2023.

The BC Air Access Program provides up to 90% funding for minor projects that improve aviation infrastructure. In 2023, the Village utilized this funding to install gravel adjacent to the south side of the runway and taxi way. The gravel was placed to slow the deterioration of the asphalt on the runway which was cracking and breaking way as the underlying gravel was washed away. The 2023 project included painting the runway and taxi way markings. Aim point and landing markings were also added to bring our runway into compliance with Transport Canada regulations.

The proposal for 2024 is to apply for a minor project. The project is for the placement of gravel along the north edge of the runway. The same problem is plaguing that area: sand and gravel is being washed away and the asphalt is cracking and breaking off. By placing gravel along the edge of the tarmac and compacting that gravel in place, this will drastically slow the deterioration of the tarmac.

Administration has acquired a quote from a local contractor for the cost of suppling, hauling and compaction of 1,100 m3 of gravel to the airport. The quote is for \$30,700.00 plus tax.

MOVED/SECONDED to apply to the BC Air Access Program for a 2024 Airport Runway improvement project that would apply and compact 1,100 yards of gravel along the north side of the runway at a cost of \$30,700.00 and to expend the \$3,700.00 portion belonging to the Village from the Northern Capital and Planning Grant reserve.

Staff Reports:

Intern L. Hartman – Celebrate Canada Funding – Funding Opportunity
The Celebrate Canada funding program provides funding to community-based activities celebrating and promoting Canada's cultural, ethnic, linguistic, and geographic diversity.

Every year the Celebrate Canada Grant from Canadian Heritage is available for municipalities to apply for funding up to \$5,000.00 which can be used towards Canada Day expenses. Project-related expenses such as fireworks, entertainment, supplies, and equipment are eligible through this stream. In 2023, the Village was successful in obtaining \$3,840.00 from this fund.

Mayor Storey suggested a parking bylaw, or signage about not parking overnight.

Mayor Storey attended a meeting on November 8th with a colleague from UBCM. This colleague was heading into an all-day budget discussion meeting. Mayor Storey is hoping that the Village of Fraser Lake can begin our budget discussion meetings earlier this year. She is hoping that the process can be easy this year and not cause headaches for Staff.

CAO Holland informed Council that Staff have started the process which includes identifying projects, prioritizing those lists and seeking quotes. He invited Council to join the next meeting if they would like to.

Mayor Storey received some complaints about the Christmas lights going up on the outside of the shopping centre before November 11th.
