### **Overview:**

The Fraser Lake RCMP 2023 Mayor's report for the period of January 1, 2023 to December 31, 2023.

Statistics are documented as they are reported and do not capture specific data therefore can be interpreted in a variety of ways. For example, a traffic offence may be reported as such, however upon investigation it may be determined that there was no actual traffic offence related to that incident, although a call for service was generated and acted upon. Conversely, a reported traffic offence can lead to an investigation into multiple Criminal Code offences that would alter the data. Data is quite fluid and ever changing. The "scoring" or "classification" of crimes changes frequently throughout an investigation which can alter the statistics throughout the life of the investigation.

An analysis of calls for service in 2023 for the Village of Fraser Lake showed an overall increase in violent criminal code occurrences such as Assaults (+14.29%), Sex Offences (+20%) and Utter Threats (+183.33%). Despite this, the increase in Criminal Code Occurrences overall was only a 2.08% increase from 431 to 440.

The total call volume or "calls for service" **specific to** the Village of Fraser Lake for the period of January 1, 2023 to December 31, 2023 was **501.** This is compared to **568** during the same time in 2022, an **11.79%** decrease. By comparison, the total calls for service received for Fraser Lake Detachment overall in 2023 was 1371. This is an **8.6%** decrease from 2022 (1500), likely attributable to the absence of the pipeline camp in the area.

### COMMUNITY BASED PROBLEM SOLVING

### **Crime Reduction:**

Fraser Lake Detachment continued to work with Stellat'en leadership and community members in 2023 to solve various issues. This, combined with intelligence led policing strategies, identified some prolific/habitual criminal offenders resulting in on-going RCMP investigations to disrupt criminal activity in the community. Strategic deployment of resources, focusing on those who commit the most crime through enforcement action to suppress criminal activity will continue in the coming year.

All members of the detachment are engaged in supporting various crime reduction initiatives. Working in conjunction with our partners Vanderhoof Community Corrections and neighboring Detachments to share information, monitor and hold offenders accountable.

During this past year the Fraser Lake members made efforts to have a presence in the Stellat'en community both at community events such as the AGM, Wellness Fires, and Gordie's birthday. Further to this we documented 283 proactive patrols which were not file related in the Stellat'en community. This police presence will increase in the coming year which can only benefit the relationship between the RCMP and the Stellat'en people.

### **Traffic:**

Fraser Lake RCMP continues to place a strong emphasis on education and enforcement relating to traffic issues. Strategies continue to be developed in an effort to reduce the incidents of high risk driving behaviors. These are both enforcement and education based strategies. There are a variety of reasons that contribute to traffic statistics; including population increases, weather conditions, road closures, education and enforcement efforts.

Detachment members continue to partner with ICBC, School District 91, the Commercial Transport Vehicle Enforcement and North District Traffic Services on a variety of traffic enforcement initiative. Further to this, Fraser Lake Detachment members routinely conduct pro-active speed enforcement within the Village of Fraser Lake resulting in several Warnings and Violation Tickets being issued to offenders.

The following traffic stats comparison is for the entire Fraser Lake Detachment area, not just specific to the Village of Fraser Lake.

### **HIGHLIGHTS**

### **Staffing Resources:**

Staffing resources crippled the Fraser Lake RCMP in 2023. During the course of the year the Fraser Lake RCMP's staffing levels reached a critical point with the Detachment Commander being the only Fraser Lake member working for a period of time. We were able to continue to focus on Core Policing with the assistance of Provincial Support Team members and overtime members from neighboring Detachments. Unfortunately, this had a negative impact on Enhanced Policing activities. Going into the 2024 fiscal year we have seen an increase in members and we anticipate being able to make more time to attend those important events in the community.

As of right now we have 1 Sergeant and 3 Constables operational. I have received approval to fill the 4<sup>th</sup> Constable position and anticipate this being filled before the end of the summer.

We have 1 Constable moving on in June and being replaced by an experience member with no gaps between moves.

The RCMP has begun the process to purchase 2 additional homes in the Village which will give us a total of 5.
